The following is an explanation of terms and conditions governing the submission of films to the 2025 edition of GREENMOTIONS FILMFESTIVAL.

By accepting these Terms and Conditions, the submitting entity confirms that they have obtained consent from all relevant parties, including owners, creators, writers, producers and/or any other authorized representatives of the film. Furthermore, the submitters affirms that they have thoroughly read and understood the submission rules and regulations detailed below:

## **I. ELIGIBILITY**

**NOTE:** Participation is open to all. The festival welcomes films produced using any technique, including animation, documentary, drama, experimental or artistic films, and hybrid work, regardless of budget size.

### **1. SHORT FILM SELECTION:**

- Films must have a running time of 20 minutes or less, including credits, unless they fit the special topic of the year (see below).
- Only films completed between 2023 and 2025 are eligible. Films completed before December 31st, 2022, will be automatically disqualified.

### **2. FEATURE FILM SELECTION:**

- Films must have a running time between 20 and 120 minutes, including credits, unless they fit the special topic of the year (see below).
- While a premiere status is not mandatory, it will be considered during the selection process and, if selected, will be highlighted in our communications.
- Only films completed between 2023 and 2025 are eligible. Films completed before December 31st, 2022, will be automatically disqualified.

### **3. SPECIAL TOPIC 2025: CLOSING THE LOOP: living within planetary boundaries**

- Films submitted should have a running time of up to 120 minutes, including credits.
- While a premiere status is not mandatory, it will be considered during the selection process and, if selected, will be highlighted in our communications.
- Only films completed between 2023 and 2025 are eligible. Films completed before December 31st, 2022, will be automatically disqualified.

### **4. KIDS & YOUNG AUDIENCE SHORT FILM SELECTION**

- Films must have a running time of 45 minutes or less, including credits, and be suitable for a young audience.
- Only films completed between 2020 and 2025 are eligible. Films completed before December 31st, 2019, will be automatically disqualified.

## **5. OUR GOAL**

Greenmotions Filmfestival aims to engage audiences with films that address current and future environmental issues, encouraging them to become active participants in the transition to a more sustainable world. Therefore, movies submitted can touch upon topics such as: food security and sustainable agriculture; access to affordable, reliable,

sustainable and modern energy for all; economic models that take into account the limits of our planet's resources as well as the need for decent work and living conditions for all, regardless of class, religion, origin or gender; sustainable consumption and production patterns; fair ways of combating climate change and its impacts on a local and global scale; a sustainable use and management of terrestrial and marine ecosystems; the development of sustainable cities and regions; etc. Our festival places a strong focus on solutions, and may prioritize films that focus on concrete actions that can be taken to achieve a more sustainable future.

## **6. RESUBMISSION POLICY:**

Films that have been previously submitted to the festival may be resubmitted, provided that they have not yet been featured in the program and were completed after December 31st, 2022 (see above).

## **7. LANGUAGES AND SUBTITLES:**

- Films in any language are welcome for our adult audience. For films in languages other than German or English, German or English subtitles are required.
- If resources allow, we will adapt subtitles to include both German and English. Therefore, providing German and/ or English transcripts is appreciated when subtitles are not available.

## **II. ENTRY PROCEDURE**

### **1. SUBMISSION DEADLINE:**

The deadline for film submissions is April 15, 2025.

### **2. SUBMISSION PROCESS VIA FILMFREEWAY:**

- During submission, please select only one category for your film:
  - Short Film
  - Feature Film
  - Special topic
  - Kids & young audience
- A single filmmaker may submit more than one film, but each submission should be made separately.

### **3. TECHNICAL REQUIREMENTS:**

- All submitted films must be of high video quality (minimum 1080p HD) and have good audio quality. Please include at least one still image from the film

- In addition to the screening copy, submitters should provide a trailer, the official poster, and promotional images.

#### 4. SELECTION NOTIFICATION:

If your film is selected, our team will contact you via email with an official acceptance message, detailed instructions for submitting screening copies, and additional information about the next steps. We strongly recommend regularly checking the email account used for submission.

#### 5. SCREENING COPY SUBMISSION:

- Please submit two high-quality digital screening copies: one in **.mov or .mp4** format and, if possible, another in **DCP** format, via a download link.
- If there are issues with digital transfer, a physical copy (Data-DVD, Blu-ray, hard drive, or USB drive) will be required.

- Note that shipping costs for screening copies will not be reimbursed; however, the festival will cover the cost of returning the copy by post.

#### 6. COMPENSATION POLICY:

Greenmotions Filmfestival is a small festival organised by a non-profit organisation and run mostly by volunteers. Due to limited resources, we therefore have limited means for the screening fees. Depending on our fundraising efforts, we offer a **non-negotiable** flat rate of **up to €150 per feature film and up to €50 per short film**. **Given our track record, the likelihood of being able to pay these fees is high.**

**By submitting your film, you agree to this flat rate.**

#### 7. ADDITIONAL SCREENINGS:

In addition to the main festival event, Greenmotions Filmfestival organises individual film screenings throughout the year. Our objectives are to spread impactful messages widely, to provide recognition to films, the filmmakers and their teams, and to inspire and motivate individuals to take action towards creating a more sustainable world. Therefore, we would appreciate it if filmmakers could grant us permission to screen their films outside the main festival, with the understanding that the flat rate cannot be increased. If we are interested in screening a selected film at additional events, our team will contact the filmmakers in advance. ### **III. FILM EVALUATION AND SELECTION PROCESS**

#### **1. EVALUATION AND FILM REVIEWING**

- All submitted films will be evaluated based on specific criteria, including appropriate content, maximum duration, etc. Films will be approved or rejected accordingly.
- An independent selection committee, appointed by the festival, will review all submissions for program consideration. Pre-selected films will be announced by mid-July 2025 via email. Please ensure you provide a valid email address and allow emails from the domain: **greenmotions-filmfestival.de**

#### **2. SHORT FILM CATEGORY**

- A pre-selection will be submitted to a jury, who is responsible for selecting the winner of the Short Film Award (see below) and determining which films will be screened at the festival.
- The winner of the short film competition will be announced at the award ceremony during the festival.
- Additionally, a selection of short films may be shown, out of competition, at school events for educational purposes. No additional screening fee will be provided for these events. If you do not consent to these additional screenings, please inform us by sending an email to [films@greenmotions-filmfestival.de](mailto:films@greenmotions-filmfestival.de).

#### **3. FEATURE FILM CATEGORY**

- Feature films will be nominated for an Audience Award (see below).
- The winner will be announced at the award ceremony during the festival.

#### **4. SPECIAL TOPIC CATEGORY**

- Films submitted for the Special Topic Award will initially be reviewed by an independent selection committee, which will select 5 to 10 films for further evaluation by a jury. This jury will determine the winner of the category.
- The festival team reserves the right to screen only a part of the nominated films and may also choose to screen other films in this category out of competition. Filmmakers will be informed if their film is scheduled to be screened in or out of competition.

#### **5. KIDS & YOUNG AUDIENCE CATEGORY**

- Films selected for the festival program will be nominated for the Kids & Young Audience Award.
- The winner will be announced at the award ceremony during the festival.
- Additionally, a selection of short films may be shown at school events for educational purposes. No additional screening fee will be provided for these

events. If you do not consent to these additional screenings, please inform us by sending an email to [films@greenmotions-filmfestival.de](mailto:films@greenmotions-filmfestival.de).

#### IV. PRIZES & AWARDS

We offer four prizes, with a maximum amount of €1.500 each for the winners in the feature film categories and €1.000 each for the winners of the short film category and the kids film category. The exact prize amounts may vary based on the fundraising achieved throughout the year. Two distinct juries, comprising filmmakers, journalists and/ or experts, will select the winners in the short film competitions and the special topic award category. In the other two film categories, the winner is chosen by the audience. Please note that each short or feature film can only participate in one competition category: Audience Award, Special Topic Award, Short Film Awards or Kids & Young Audience Award.

#### V. VISITING THE FESTIVAL

- Greenmotions Filmfestival exists because we believe in the power of cinema to foster constructive discussions and drive positive change. We highly value engaging discussions with filmmakers and/ or their teams. Therefore, we are happy to invite directors and their teams to join us online after the screening or to attend the festival as our guests.
- Please note that as a small festival organised by a non-profit organisation, we face budget constraints that limit our ability to cover expenses. **We can only offer partial reimbursement for transportation costs, up to a maximum of €100 per film, to filmmakers and their team.** If you need support, please contact us by sending an email to [films@greenmotions-filmfestival.de](mailto:films@greenmotions-filmfestival.de).
- We strive to arrange local private accommodations for festival attendees. More information about hosting services will be provided individually to successful applicants.
- Given the limited compensation for travel, we also host online Q&A sessions after the screenings to ensure filmmakers have the opportunity to engage with the audience. If the director or producer of the film is unable to attend the festival, the invitation may be extended to another member of the film crew or participants involved in the film.

#### VI. LIABILITY

1. The sender submitting the film is responsible for ensuring all copyrights are in order.
2. The applicant must have the legal authority to submit the film to the festival and, if selected, to grant permission for its screening.

3. The applicant must have secured all necessary rights for both visual and audio elements of the film. The exhibition of the film must not violate or infringe upon any rights, including, but not limited to, those related to music, images, and content.
4. The applicant warrants that the submitted material does not defame or infringe upon the rights of any individual, living or deceased. The applicant agrees to fully indemnify the Greenmotions Filmfestival against any claims made for such violations of law.
5. The applicant agrees to hold the Greenmotions Filmfestival harmless from and to defend them against all claims, demands, losses, damages, judgements, and liabilities.
6. The film, including all copyrights, remains as a property of the author. Greenmotions Filmfestival retains the right to use the submitted material for non-commercial purposes, such as publicity, promotion and graphics. In case the footage from the submitted film is used for festival promotion, Greenmotions Filmfestival will limit this usage to not more than one minute.
7. The festival reserves the right to adjust the prize amount based on its present budget.
8. The applicant must read and accept the regulations and guidelines to participate.
9. Failure to comply with these terms and conditions may result in the disqualification of the submission.
10. In the event of any disagreement regarding the interpretation of the terms and conditions, the interpretation provided by the Greenmotions Filmfestival will be considered authoritative and will take precedence.
11. These regulations are subject to change. In case of any replacement, all participants will be informed by email.
12. This agreement is governed by the laws of the State of Baden-Württemberg, Germany, and applies to agreements that are entirely executed within this jurisdiction.
